Welcome to our unit and thank you for agreeing to take part in this Clinical Trial. We aim to make your stay as comfortable as possible.

We have some "house rules" for you to follow throughout your stay that are pertinent to the study you are participating in. The ticked boxes below will indicate the restrictions that are applicable to you.

If you have any questions regarding these restrictions the unit staff will be more than happy to help address your queries.



■ Mobile phones are allowed on the unit; however these must not be used whilst study procedures are being performed. Camera functions on mobile phones must not be used whilst on the unit.



☐ There **may** be restrictions on the food and drinks you can consume while you are on the unit. This may include the amount of fluids you can consume or the amount of calories we need you to eat. This restriction will also mean you will **not be** allowed to drink alcohol.



You must **not** take any herbal or prescribed medications without informing unit staff for the duration of this trial.

If there is reason to believe alcohol or drug use has occurred during a study we will request that you be tested for those substances. Refusal to take the test and/or positive results could disqualify you from the study.



There will be restrictions about leaving the unit, you will not routinely be allowed to walk around the hospital grounds. All of the doors on the unit are locked and can only be accessed by using a swipe card.

Friends/relatives are not permitted to visit during studies.



This hospital is a non-smoking site – you will not be permitted to smoke inside the unit and as you are not permitted to leave the unit during your stay you will therefore not be allowed to smoke cigarettes. There may be an opportunity, depending on the trial, for you to have nicotine replacement therapy.



There **may** be some specific rules around visiting the bathroom – this may be because we need to collect samples from you, therefore the bathroom doors may be locked. Staff will unlock the bathroom for your use and provide the collection container, if required. Depending on the study you are enrolled into we may need you to shower (or not) at certain times of the day.

Your bag will be checked on arrival at the unit restricted items will be taken from you and kept securely before being returned to you upon departure of the unit. These items are detailed on the in-patient check list.
